The General will be a Signal for Striking Tents by which time the Officers Commanding Officers of Companies will that there respective Companies are Victualled, and in perfect readiness to March, That there Tents are lyed up in proper order without their poles and that Each Non Commission Officer & Private, Carry their Packs Provisions Camp Kettles, & the Arms of their Companies — The Quarter Master will see that the Copanies are Supply'd with Four Axes Each, Including those at present in their possession — Serj' Holister is to remain at this post with the Artillery man & Invalids to take Charge of all Public Store, Ordnance &c. &c. —

*All Officers commanding Companies are to be car*[crease] full in attending the distribution of the provisions of their respective *compan*[creased] and see that due bills are regularly obtain'd for retrained parts of Rations at least half Gill of Rum or Whiskey is to be retain'd out of Each Non Commission'd Officer and privates Ration, at the Expriation of every Month, th[creased] due bills for all retain'd parts of Rations are to be delivered to the pay maste[creased] who is to call on the Contractors for the pay of those due bills and keep accounts [creased] the moneys retained for such retained Rations giving Credit to each Company for the particular Sums received on account of the company—these monies as fa[creased] as respect the Levies are to be laid out in Shoes and other necessary articles to enable those troops to be at all times in a Situation to do their duty. And as far as they respect the Two years Men they will be employed in ornamenting and for other purposes proper for the uniformity and good order of those troops. Each Company is to have one or more Soldiers or their Wives employed as Taylors and Shoemakers to mend the Mens Cloaths & Shoes for which a reasonable allownace will be made them out of the moneys receive[creased] for retain'd parts of Rations. But no account is to be paid otherwise than by Order from the Officer Commanding the Company Countersigned by the Commandant of the Regiment.

Lieut<sup>nt</sup> Colo<sup>l</sup> Commandant Reid & Colo<sup>l</sup> Willett will be pleased to furnish the Commanding General as soon as they conveniently can with their Claims in Writing — Lieut<sup>nt</sup> Class R.Q.M. is to make out returns of provisions at this post, who will make out a weekly Return on Monday to be delivered at the ordinary Office — No provisions at any post within this department is to be issued to any person but such as are in actual Service and agreeable to the last arrangements, Excepting on the Special Order of the Commander in Chief, or of the Secretary at War. — The deputy Quarter Master is immediately to prepare Quarters in the barricks for Six Commissioned Officers & for One hundred Non Commissioned & Privates. — M<sup>r</sup> Bell prison keeper is immediately to make return of all military prisoners now in

custody, the Regiment or Corps they belong to by whom and how long confin'd with the Crimes or reason of confinement, the Orderly Office will be at the house of M Donte near the Markett, Orders will be issued at Twelve OClock precisely.

## Head Quarters Albany 12th September 1782.

The troops as they arrive in this City will repair to the barracks and apply to the deputy  $Q^r$  Master for the particular rooms he has assigned them agreeable to the General Order of the  $10^{th}$  Instant.

## *After Orders September the 12<sup>th</sup> 1782/.*

A Corporal and four privates to be sent to the Commissaries to morrow morning by Sun rise they will take provisions Sufficient to Subsist them to Fort Hunter — to which place are to guard a number of Cattle the Cattle will be under the direction of a drover to be furnished by the Contractors — This Guard will be relieved at Fort Hunter & Return immediately the relief to consist of a Corporal and Eight privates to be furnish'd by the Officer Commanding at that post this guard will escort the Cattle to Fort plain

## Head Quarters Albany 13th September 1783.

The prisoners arrived from in this City from Canada will be quartered in some Convenient rooms in the Hospital which Doctor Young will be pleased to point out untill such times as they can be forwarded by water to New Windsor they will be allow'd provisions during the time they remain at this palce upon an order from Head quarters the D. Q' M' will furnish them with wood, Cap' Sherwood will Please to deliver a List of their Names at the orderly Office —

An abstract of goods in the Possession of the Quarter Master of Fort Plain on October 26, 1783: 1 tack plain, 1 hand saw, 1 cross butt saw, 117 narrow axes, 1 hammer, 1 file, 3 gimblets, 4 augers, 1 bar of iron, 2 caulking irons, 1 marquee, 9 horse tents, 34 common tents, 1 trowl, and 5 boxes of nails.
